# Cybercivility Task Force Meeting July 8, 2014

## Welcome, Outcomes and Feedback

#### Dr. David Steinberg, Facilitator

Dr. Steinberg welcomed the group and reviewed the items that were given to the task force members: agenda, subcommittee discussion notes, capture sheet and an evaluation form.

He informed the group that there would be two "report-out" segments, one before the small group work and one after they had met in their subcommittees. During the first report-out segment, a representative from each subcommittee would share what the major focus of their group had been thus far. During the second report-out segment, the subcommittees would share one deliverable that they had come to consensus on.

Dr. Steinberg shared that the subcommittees are at different stages in developing an action plan and given the limited time the group has had at the meetings, the Office of Communications would like to add at least two more meetings (September-October) and would like to know if the group is willing to continue working on the task force.

Some task force members mentioned at the last meeting that they would be out of town during the August 5 meeting.
